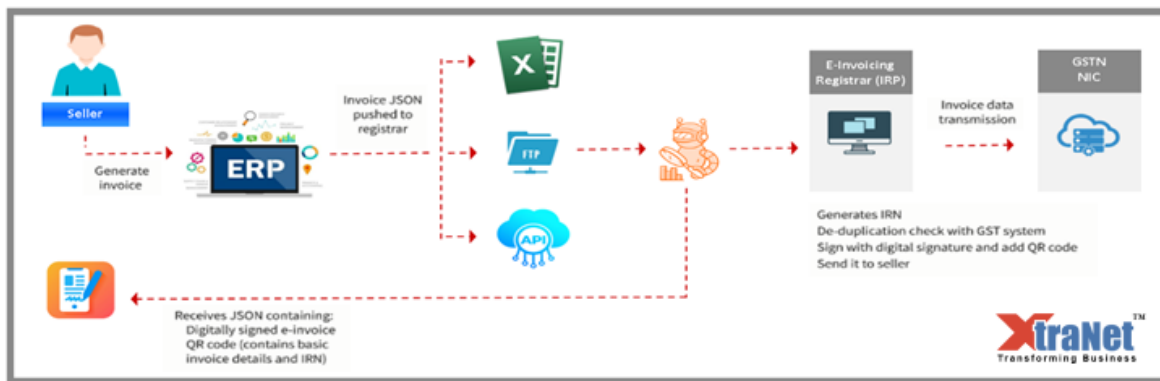


E-INVOICE MANAGEMENT SYSTEM

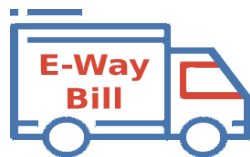

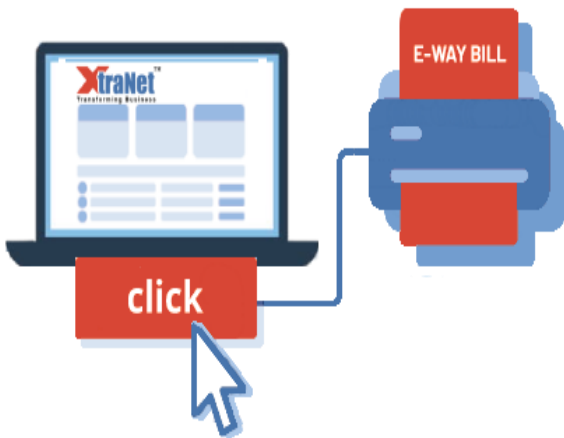
